ITEM TITLE: RATIFICATION OF WARRANT REGISTER FOR THE PERIOD FROM NOVEMBER 25, 2023, TO JANUARY 5, 2024. (0300-25)

EXECUTIVE SUMMARY:

BACKGROUND/ANALYSIS:
